

**FINAL NOTICE AND PUBLIC EXPLANATION OF PROPOSED ACTIVITIES  
IN 100-YEAR/500-YEAR FLOODPLAINS AND/OR WETLANDS**

TO: ALL INTERESTED AGENCIES, GROUPS AND INDIVIDUALS:

This is to give notice that Fayette County, PA has conducted evaluations as required by Executive Order 11988 and/or 11990, in accordance with HUD regulations at 24 CFR 55.20 Subpart C Procedures for Making Determinations on Floodplain Management and Wetlands Protection. The activity is funded under FY2022 CDBG-CV Discretionary Program (Contract Numbers: C000083139). Proposed project(s) is located in various areas throughout Fairchance Borough and at any future sites for similar projects throughout Fayette County, PA for water system improvements.

The identified action will provide funding to make water system improvements including 8,550 LF of waterline replacement and upgrades to fire hydrants to improve the overall water system and fire safety for residents in Fairchance Borough. The total number of linear feet involved in a Special Flood Hazard Area (Zone AE) floodplain is approximately 734 LF. Fayette County also reviewed future similar actions involving water system improvements whereas the existing waterlines or a portion of waterlines is located in a predicted floodplain and/or wetland area throughout Fayette County, including the entitlement townships of Bullskin, Dunbar, Georges, German, Luzerne, Menallen, North Union, Redstone, and South Union Townships for their effect on passage of floodwaters, alternatives to floodplain development, and for consistency with federal, state, and local policies and regulations on floodplain management. The total number of linear feet and type of floodplain/wetland area for future projects is yet to be determined.

Fayette County, PA has considered the following alternatives and mitigation measures to be taken to minimize adverse impacts, and to restore and preserve natural and beneficial values: relocation and/or revision of the activity, and no action were considered; however, it was determined that neither of these options would provide the same benefit as the activities involve water system improvements of existing waterlines.

Fayette County, PA has re-evaluated the alternatives to undertaking this or similar activities in floodplains and/or wetlands and has determined that it has no practicable alternative. Environmental files that document compliance with steps 3 through 6 of Executive Order 11988 and/or 11990, are available for public inspection, review and copying upon request at the times and location delineated in the last paragraph of this notice for receipt of comments.

There are three primary purposes for this notice. First, people who may be affected by activities in floodplains and/or wetlands and those who have an interest in the protection of the natural environment should be given an opportunity to express their concerns and provide information about these areas. Second, an adequate public notice program can be an important public educational tool. The dissemination of information and request for public comment about floodplains and/or wetlands can facilitate and enhance Federal efforts to reduce the risks and impacts associated with the occupancy and modification of these special areas. Third, as a matter of fairness, when the Federal government determines it will participate in actions taking place in floodplains/wetlands, it must inform those who may be put at greater or continued risk.
